July	1983	Increases capital to 9 million yen.
March	1984	Relocates the Head Office to a new building at Chuo, Yamato city, Kanagawa.
May	1984	Increases capital to 18 million yen.
July	1984	Establishes Kita-Kanto Sales Branch Office in Oyama city, Tochigi prefecture.
September	1984	Begins sales of original product DC-DC converter.
June	1988	Increases capital to 45 million yen.
March	1989	Establishes Suwa Sales Branch Office in Suwa city, Nagano prefecture.
June	1989	Expansion of the Head Office.
February	1990	Begins design, production and sales of switched-mode power supply.
April	1991	Establishes Nagano Local Office in Nagano city, Nagano prefecture.
February	1996	Changes Nagano Local Office to Nagano Sales Branch Office.
February	1998	Establishes Tohoku Sales Branch Office in Sendai city, Miyagi prefecture.
February	2003	Changes Tohoku Sales Office to Sendai Branch Office and integrates into Kita-Kanto Sales Office.
April	2004	Integrates Suwa Sales Office into Nagano Sales Office.
December	2005	Acquisition of ISO14001 (2004) certification.
December	2012	Establishes Fujiwa Hong Kong Ltd.
